  - Development Monitor – Anita
    1. **SW Yandina.** Request for minor change to approved plans. Reduce length of required Bracken Fern Road pavement widening. Relocate proposed cul-de-sac on Creightons Road north. Reduction in shared path width on eastern side of Road A to 2,5 metres. Removal of shared pathway on Nambour North Connection Road either side of Wappa Falls Road with proposal to enter into an infrastructure agreement with Council pertaining to the works.

2. **55 Hutton Road, Kiamba** (function and accommodation facility): Information request. 16 issues related to rural zone code. (Traffic, noise, visual amenity, proximity to neighbour etc.)

3. **Terella Brewery**: Extension agreement to respond to Council's information request until 21.08.25. Note: Further extension unlikely to be supported.

4. **Halcyon retirement facility**: approval for earthworks, roadworks and drainage to Steggalls Road frontage.

5. **81 Creightons Road, Kulangoor**: Application for short-term tourist accommodation (eight cabins) – extension period to comply with action notice until 08.08.25.

6. OPW. **Access off Ninderry Road to residential development at 86 -92 Farrell Street.**

7. 1 & 3-7 Old Gympie Road. **Extension of retail centre.** Amended plans; 2 additional shops, outdoor seating, enclosed loading bay, dog wash.

8. 1679 – 1681 **Car wash.** Minor change to development approval. Rotation of dog wash / auto wash bays.

9, **Winston Timbers**, 48 Central Park Drive, Yandina: Extension to existing building; additional industrial building and additional vehicular access. SARA extension 19.09.25

10. **Yandina Hotel**: SARA extension until 26.08.2025.
